Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.13%) lost 6.98 points and closed at 5,344.05. The blue-chip index DS30 (+0.02%), the Shariah-based index DSES (-0.02%), and the large-cap index CDSET (-0.10%) closed at 2,067.03, 1,162.08, and 1,099.17 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 1.20%, followed by Fuel & Power (+0.61%), Bank (+0.27%), Telecommunication (+0.19%),Engineering Pharmaceutical (-0.49%), and Food & Allied (-0.76%), respectively. Block trades contributed 2.0% of the overall market turnover. Bangladesh Shipping Corporation (+2.9%) was the most traded share with a turnover of BDT 209 million.




