## **Daily Market Update**

Market closed in green

The market closed in green today. The benchmark index DSEX (+0.44%) gained 21.99 points and closed at 4,963.83. The blue-chip index DS30 (+0.22%), the Shariah-based index DSES (+0.27%), and the large-cap index CDSET (+0.02%) closed at 1,903.29, 1,034.47, and 1,023.09 points, respectively. Most of the large-cap sectors posted positive performance today. NBFI booked the highest gain of 1.09% followed by Food & Allied (+0.95%), Engineering (+0.67%), Pharmaceutical (+0.39%), Bank (+0.17%), Fuel & Power (-0.33%), and Telecommunication (-1.06%), respectively. Block trades contributed 5.1% of the overall market turnover. Simtex Industries Limited (+0.9%) was the most traded share with a turnover of BDT 156 million.




