Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.62%) lost 30.87 points and closed at 4,932.97. The blue-chip index DS30 (-0.62%), the Shariah-based index DSES (-0.62%), and the large-cap index CDSET (-0.53%) closed at 1,891.49, 1,028.01, and 1,017.66 points, respectively. All the large-cap sectors posted negative performance today. Telecommunication experienced the highest loss of 1.87% followed by NBFI (-1.56%), Bank (-0.75%), Fuel & Power (-0.70%), Engineering (-0.68%), Food & Allied (-0.36%), and Pharmaceutical (-0.22%), respectively. Block trades contributed 3.6% of the overall

market turnover. Orion Infusion Ltd. (+1.5%) was the most





Figure: Sectorial Turnover (BDT Mn)
