


Daily Market Update

The market closed in green today. The benchmark index DSEX (+0.76%) gained 39.05 points and closed at 5,193.36. The blue-chip index DS30 (+0.54%), the Shariah-based index DSES (+0.81%), and the large-cap index CDSET (+1.11%) closed at 1,997.23, 1,042.87, and 1,094.58 points, respectively. Large-cap sectors posted mixed performance today. Bank booked the highest gain of 3.09%, followed by NBFI (+0.72%), Pharmaceutical (+0.35%), Engineering (+0.32%), Fuel & Power (-0.12%), Food & Allied (-1.02%), and Telecommunication (-1.67%), respectively. Block trades contributed 4.1% of the overall market turnover. Dominage Steel Building Systems Limited (+9.8%) was the most traded share with a turnover of BDT 239 million.




