


## Daily Market Update

The market closed in green today. The benchmark index DSEX (+1.18%) gained 59.82 points and closed at 5,140.39. The blue-chip index DS30 (+1.36%), the Shariah-based index DSES (+1.22%), and the large-cap index CDSET (+1.36%) closed at 1,976.94, 1,034.43, and 1,071.92 points, respectively. All of the large-cap sectors posted positive performance today. Bank booked the highest gain of 2.59% followed by NBFI (+1.45%), Pharmaceutical (+0.99%), Fuel & Power (+0.80%), Telecommunication (+0.53%), Food & Allied (+0.50%), and Engineering (+0.17%), respectively. Block trades contributed 4.8% of the overall market turnover. Orion Infusion Ltd. (+4.5%) was the most traded share with a turnover of BDT 259 million.





