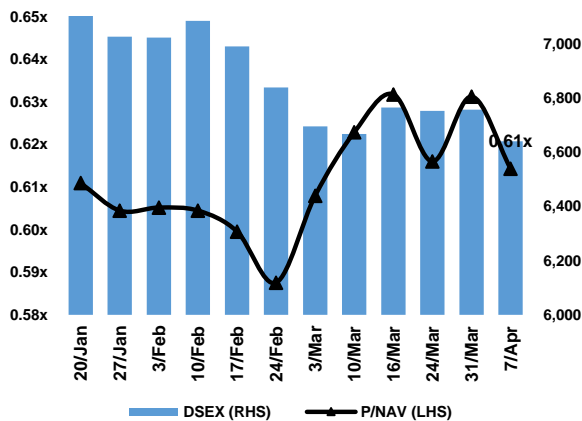


Weekly Report on Mutual Funds

April 10, 2022

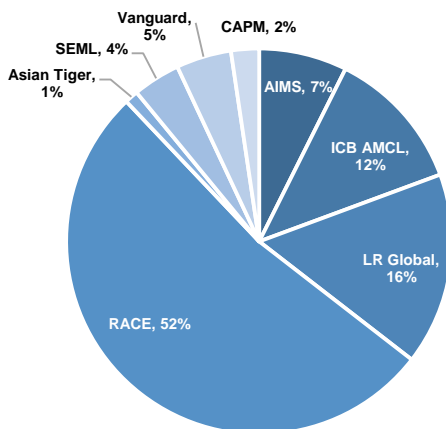
Chart 1 - Change in weighted average Price to NAV ratio of

The fund managers have reported NAV of the closed-ended mutual funds for the week ending on April 07, 2022. Based on the recently reported NAV and today's (April 10, 2022) close prices, the sectoral Price to NAV stood at 0.61x, lower than last week's Price to NAV of 0.63x. On average, price of the mutual funds decreased by 3.60% and NAV of mutual funds decreased by 0.94% from previous week against a negative 1.73% WoW change in DSEX. Among all the asset managers, CAPM performed the best in terms of NAV return of its funds, gaining 0.25% during the week. Among the 35 mutual funds, 31 of them were trading at discount. Market capitalization of 35 funds stood at BDT 38.2 billion (USD 452.1 million), while the Asset Under Management (AUM) of the sector stood at BDT 62.2 billion (USD 736 million). RACE holds the highest market share of 52.4% with 10 funds and AUM of BDT 32.6 billion. The fund manager has the lowest Price/NAV ratio of 0.49x, while LR Global stood at the second lowest Price/NAV ratio of 0.65x. The average daily turnover of the sector stood at BDT 78.9 million in the last trading week, which was 25.4% lower than the previous week's turnover value.

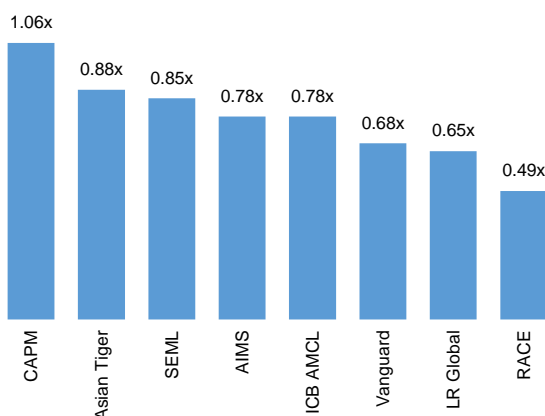

Chart 4 - YTD NAV Return of Mutual Funds:

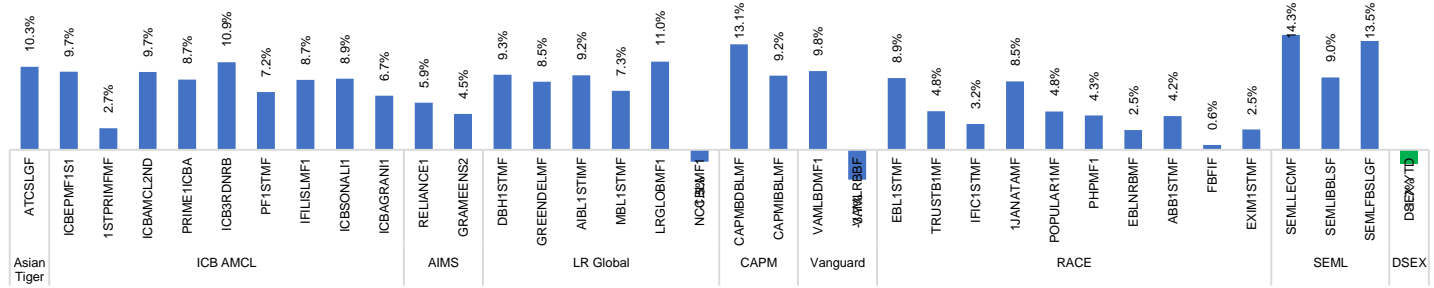
