
DSEX Index Closing 7,196.32 ↑ (+55.45, +0.78%)

Market closed in green

The market closed in green today. The benchmark index DSEX (+0.78%) gained 55.45 points and closed at 7,196.32. The bluechip index DS30 (+1.15%), the Shariah-based index DSES (+1.30%), and the large-cap index CDSET (+0.96%) closed at 2,613.54, 1,571.91, and 1,415.88 points, respectively. Largecap sectors posted mixed performance today. Food & Allied booked the highest gain of 1.66% followed by Pharmaceutical (+1.32%), Bank (+0.90%), Telecommunication (+0.50%). Engineering experienced the highest loss of 0.8% followed by NBFI (-0.20%), Fuel & Power (-0.06%). Block trades contributed 1.3% of the overall market turnover. Square Pharmaceuticals Ltd. (+3.2%) was the most traded share with a turnover of BDT 990 million.


