
# **Daily Market Update**

Market closed in red today. The benchmark index DSEX (-0.67%) lost 37.61 points and closed at 5,552.81 points today. The blue-chip index DS30 (-0.48%) and the shariah based index DSES (-0.26%) both closed in red. All the large cap sectors showed mixed performance today. Telecommunication posted the highest gain of 0.53% followed by NBFIs (+0.22%) and Pharmaceuticals (+0.05%). Banks experienced the highest loss of 1.49% followed by Power (-0.87%), Food & Allied (-0.36%) and Engineering (-0.29%). Total turnover stood at BDT 7.2 billion (USD 86.2 million). Khulna Power Company Limited (+5.1%) was the most traded share with a turnover of BDT 654.4 million.
