The market closed in green today. The benchmark index DSEX (+1.36%) gained 57.39 points and closed at 4,271.82. The blue-chip index DS30 (+1.56%), the Shariah-based index DSES (+1.70%), and the large cap index CDSET (+1.18%) closed at 1,442.79, 993.14, and 840.09 points respectively. All the large cap sectors posted positive performance today except NBFI (+0.19%), and Bank (-0.08%). Pharmaceutical booked the highest gain of 2.12% followed by Engineering (+2.04%), Telecommunication (+1.91%), Fuel & Power (+0.97%) and Food & Allied (+0.46%). Block trades contributed 3.4% of the overall market turnover. Square Pharmaceuticals Ltd. (+3.3%) was the most traded share with a turnover of BDT 305 million.


