Daily Market Update


Market closed in green today. The benchmark index DSEX (+0.27%) gained 14.22 points and closed at 5,201.42 points today. The blue chip index DS30 (+0.75%) and the shariah based index DSES (+2.24%) both closed in green. All the large cap sectors showed positive performance today except Telecommunication (-0.18%). Power posted the highest gain of 0.76% followed by Food & Allied (+0.75%), Engineering (+0.38%), NBFIs (+0.20%), Pharmaceuticals (+0.14%) and Banks (+0.12%). Turnover stood at BDT 4.1 billion (USD 49.4 million). United Power Generation & Distribution Company Ltd. (+1.2%) was the most traded share with a turnover of BDT 273.1 million.
