


# **Daily Market Update**

## DSEX Index Closing 4,703.32 ↑ (+69.94 +1.51%) Market closed in green

The market closed in green today. The benchmark index Sect DSEX (+1.51%) gained 69.94 points and closed at 4,703.32. The blue-chip index DS30 (+0.81%), the NBF Shariah-based index DSES (+0.01%), and the large cap index CDSET (+1.31%) closed at 1,594.31, 1,088.46, Gene and 939.01 points, respectively. Bank booked the highest gain of 4.41% followed by NBFI (+0.80%), Fuel & Power (+0.64%), and Telecommunication (+0.51%). Phar Food & Allied experienced the highest loss of -0.15%, Fuel Pharmaceutical (-0.46%), and Engineering (-0.55%). Cem Block trades contributed 7.0% of the overall market Serv turnover. BRAC Bank Ltd. (+4.8%) was the most traded share with a turnover of BDT 522 million. Food

#### **GSPFINANCE**

The Board of Directors has recommended 6% cash and 4.50% stock dividend for the year ended on December 31, 2019. Date of AGM: 23.09.2020, Time: 11:00 AM, Venue: Digital Platform. Record Date: 03.09.2020. The Company has also reported Consolidated EPS of Tk. 1.46, Consolidated NAV per share of Tk. 22.49 and Consolidated NOCFPS of Tk. 3.76 for the year ended on December 31, 2019 as against Tk. 2.40, Tk. 22.84 and Tk. 0.57 respectively for the same period of the previous year. The Company has also informed that i) Stock dividend has been recommended in view to utilize its retained amount as paid-up capital for improving the capital adequacy and thereby facilitate future business expansion of the Company. ii) Stock dividend is declared out of accumulated profit. iii) Stock dividend is not declared from capital reserve or revaluation reserve or any unrealized gain or out of profit earned prior to incorporation of the Company or through reducing paid up capital or through doing anything so that the post dividend retained earnings become negative or a debit balance. NOCFPS has been increased due to less outflow for Loans /Advances and Deposits.

#### BERGERPBL

(Q1 Un-audited): Consolidated EPS was Tk. 2.32 for April-June 2020 as against Tk. 11.12 for April-June 2019; Consolidated NOCFPS was Tk. (10.34) for April-June 2020 as against Tk. 20.03 for April-June 2019. Consolidated NAV per share was Tk. 206.52 as on June 30, 2020 and Tk. 204.20 as on March 31, 2020. The Company also informed that EPS for first quarter ended June 30, 2020 decreased significantly from the same period of previous year due to lower sales in April and May 2020 impacted by country-wide-lockdown for COVID 19. NOCFPS decreased significantly because of low sales resulting low collection from customers during April and May 2020 and reduction in trade and other payables.

Ms. Umme Khadiza Meghna, one of the Directors of the Company, has expressed her intention to buy 1,00,000 shares of the Company at prevailing market price (In the Block Market) through Stock Exchange (DSE) within next 30 working days.
