Daily Market Update


Market closed in green today. The benchmark index DSEX (+1.29%) gained 70.76 points and closed at 5,538.51 points today. The blue-chip index DS30 (+1.21%) and the shariah based index DSES (+0.29%) both closed in green. Large cap sectors showed mixed performance today. NBFIs posted the highest gain of 5.38% followed by Banks (+4.38%), Pharmaceuticals (+0.23%) and Food & Allied (+0.16%). Engineering experienced the highest loss of 2.09% followed by Power (-0.59%) and Telecommunication (-0.39%). Total turnover stood at BDT 5.6 billion (USD 67.4 million). BBS Cables Limited (-6.4%) was the most traded share with a turnover of BDT 244.8 million.
