


# **Daily Market Update**

DSEX Index Closing 4,827.58↑ (+46.01, +0.96%) Market closed in green

The market closed in green today. The benchmark index s DSEX (+0.96%) gained 46.01 points and closed at 4,827.58. The blue-chip index DS30 (+1.11%), the Shariahbased index DSES (+1.11%), and the large-cap index CDSET (+1.06%) closed at 1,679.05, 1,126.14, and 979.82 points, respectively. The large-cap sectors posted positive performance today except Banks (-0.46%). Food & Allied booked the highest gain of 5.78% followed by NBFI (+3.25%), Fuel & Power (+1.98%), Engineering (+1.73%), Pharmaceutical (+0.99%), and Telecommunication (+0.78%). Turnover stood at BDT 7.8 billion (USD 92.2 million). Block trades contributed 3.6% of the overall market turnover. Bangladesh Export Import Company Ltd. (-1.5%) was the most traded share with a turnover of BDT 542 million. П
