


Daily Market Update

The market closed in green today. The benchmark index 54 DSEX (+0.12%) gained 5.97 points and closed at 4,879.15. The blue-chip index DS30 (+0.56%), the Shariah -based index DSES (+0.20%), and the large-cap index M CDSET (+0.58%) closed at 1,699.55, 1,132.85, and 994.61 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 2.60% followed by Telecommunication (+0.91%), Pharmaceutical (+0.53%), and Bank (+0.35%). Food & Fu Allied experienced the highest loss of 1.75% followed by Engineering (-0.80%), and Fuel & Power (-0.10%). Block strades contributed 9.9% of the overall market turnover. Beximco Pharmaceuticals Ltd. (+6.7%) was the most traded share with a turnover of BDT 1,399 million.
