
DSEX Index Closing 4,596.00 ↓ (-75.33, -1.61%) Market closed in red

Market closed in red today. The benchmark index set DSEX (-1.61%) lost 75.33 points and closed at \overline{Ba} 4,596.00 points. Both the blue chip index DS30 (- N 1.42%) and the Shariah-based index DSES (- M 1.38%) closed in red. All the large cap sectors showed negative performance today. NBFIs experienced the highest loss of 2.41% followed by Banks (-2.11%), Power (-1.81%), Engineering (-1.33%), Food & Allied (-1.14%), Pharmaceuticals (- Ce 0.75%), and Telecommunication (-0.57%). Turnover se stood at BDT 3.5 billion (USD 42.0 million). E Sinobangla Industries (+10.0%) was the most For traded share with a turnover of BDT 146.3 million. IT т
