Daily Market Update


Market closed in red today. The benchmark index DSEX (-0.83%) lost 48.19 points and closed at 5,763.73 points today. The blue chip index DS30 (-0.07%) and the shariah based index DSES (-0.24%) both closed in red. The large cap sectors showed negative performance today except Pharmaceuticals (+1.19%) and Food & Allied (+1.15%). Banks (-2.00%) experienced the highest loss today followed by NBFIs (-1.55%), Engineering (-1.02%), Telecommunication (-0.09%) and Power (-0.05%) Turnover stood at BDT 8.13 billion (USD 97.8 million) which was 1.8% higher than the previous session's value. United Power Generation & Distribution Company Ltd (+0.5%) was the highest traded share with a turnover of BDT 665.6 million.
