
# **Daily Market Update**

Market closed in red today. The benchmark index DSEX (-0.58%) lost 27.74 points and closed at 4,740.40 points. The blue chip index DS30 (-0.51%), the large cap index CDSET (-0.53%) and the Shariahbased index DSES (-0.22%) all closed in red. All the large cap sectors showed negative performance today Telecommunication except (+0.81%)Pharmaceuticals (+0.04%). Banks experienced the highest loss of 1.31% followed by NBFIs (-1.24%), Food & Allied (-0.16%), Fuel & Power (-0.07%) and Engineering (-0.06%). Turnover stood at BDT 10.2 billion (USD 122.9 million). Summit Power (+3.8%) was the most traded share with a turnover of BDT 422.3 million.
