

## **Daily Market Update**



The large Mutual Fu cap sectors showed positive performance today expect General In Engineering (-0.30%) and Food & Allied (-0.02%). Power Life Insura highest gain followed bv (+1.06%) posted the Telecommunication (+0.80%), NBFIs (+0.58%), Banks (+0.43%) Telecomm and, Pharmaceuticals (+0.35%).
