Market closed in green today. The benchmark index DSEX (+0.37%) gained 17.61 points and closed at 4,758.01 points. The blue chip index DS30 (+0.55%), the large cap index CDSET (+0.62%) and the Shariah -based index DSES (+0.52%) all closed in green. Large cap sectors showed mixed performance today. Telecommunication booked the highest gain of 7.35% followed by Fuel & Power (+3.00%) and Engineering (+2.76%). NBFIs experienced the highest loss of -1.07% followed by Food & Allied (-0.96%), Banks (-0.88%) and Pharmaceuticals (-0.30%). Turnover stood at BDT 8.4 billion (USD 100.7 million). Summit Power (+1.4%) was the most traded share with a turnover of BDT 300.6 million.


