

# **Daily Market Update**

Market closed in red today. The benchmark index DSEX (- sector) 0.47%) lost 26.81 points and closed at 5,711.83 points today.  $\overline{_{Banks}}$ The blue chip index DS30 (-0.78%) and the shariah based NBFIs index DSES (-0.39%) both closed in red. The large cap sectors Mutual showed negative performance today except for Food & Allied General (+1.56%). Telecommunication (-1.21%) recorded the lowest Life Insu return today followed by Banks (-0.76%), Pharmaceuticals (-0.73%), NBFIs (-0.36%), Power (-0.32%), and Engineering (- Telecom 0.16%). Turnover stood at BDT 6.89 billion (USD 82.9 million) Pharma which was 1.4% higher than the previous session's value. Fuel & F United Power Generation & Distribution Company Ltd (0.0%) Cement was the highest traded share with a turnover of BDT 372.7 Services million. Enginee


