


Daily Market Update

Market closed in green

Market closed in green today. The benchmark index s DSEX (+0.13%) gained 6.00 points and closed at Ba 4,459.29 points. Both the blue chip index DS30 (- NI 0.48%) and the large cap index CDSET (-0.43%) closed in red, while the Shariah-based index DSES (+0.96%) closed in green. The large cap sectors showed positive performance today except Banks (-1.29%). Engineering booked the highest gain of 1.36%followed by Power (+0.71%), Telecommunication ce (+0.52%), NBFIs (+0.49%), Pharmaceuticals se (+0.38%), and Food & Allied (+0.26%). Turnover stood End at BDT 3.9 billion (USD 46.5 million). Khulna Power F Company Limited (+6.4%) was the most traded share with a turnover of BDT 206.4 million.
