


Daily Market Update

DSEX Index Closing 4,382.06 ↑ (+232.23, +5.60%) Market closed in green

Market closed in green today. The benchmark index SDSEX (+5.60%) gained 232.23 points and closed at 4,382.06 points. The blue chip index DS30 (+5.73%), the Shariah-based index DSES (+6.09%), and the large cap index CDSET (+5.65%) all closed in green. All the large cap sectors showed positive performance today. Telecommunication booked the highest gain of 8.68% followed by NBFIs (+7.55%), Food & Allied (+7.22%), Pharmaceuticals (+5.52%), Engineering (+5.15%), Banks (+4.90%), and Power (4.03%). Turnover stood at BDT 4.1 billion (USD 49.5 million). Square Pharmaceuticals (+8.1%) was the most traded share with a turnover of BDT 191.5 million.
