


Daily Market Update

Market closed in green

Market closed in green today. The benchmark index DSEX (+0.73%) gained 32.19 points and closed at 4,440.30 points. The blue chip index DS30 (+0.84%), the Shariah-based index DSES (+1.09%), and the large cap index CDSET (+0.76%) all closed in green. The large cap sectors showed positive performance today except Telecommunication (-1.01%). NBFIs booked the highest gain of 4.96%, followed by Food & Allied (+1.97%), Power (+1.35%), Engineering (+1.17%), Pharmaceuticals (+0.59%), and Banks (+0.05%). Turnover stood at BDT 4.4 billion (USD 52.7 million). LafargeHolcim Bangladesh Limited (+6.7%) was the most traded share with a turnover of BDT 377.1 million.


