


# **Daily Market Update**

Market closed in green

Market closed in green today. The benchmark index sec DSEX (+1.66%) gained 73.60 points and closed at Bai 4,513.89 points. The blue chip index DS30 (+1.55%), the Shariah-based index DSES (+1.66%), and the Ge large cap index CDSET (+1.28%) all closed in green. Life The large cap sectors showed positive performance today except NBFIs (-0.51%). Engineering booked Pha the highest gain of 3.80% followed by Food & Allied Fue (+3.61%). Power (+2.30%), Pharmaceuticals Cer (+1.72%), Telecommunication (+1.27%) and Banks Ser (+0.42%). Turnover stood at BDT 5.1 billion (USD Englishing) 61.9 million). LafargeHolcim Bangladesh Limited IT (+0.7%) was the most traded share with a turnover of Te BDT 312.3 million.
