Daily Market Update


Market closed in red today. The benchmark index DSEX (-0.93%) lost 49.24 points and closed at 5,273.17 points today. The blue-chip index DS30 (-1.11%) and shariah based index DSES (-0.90%) both closed in red. All the large cap sectors showed negative performance today except Power (+0.37%). NBFIs experienced the highest loss of 2.14% followed by Banks (-1.14%), Telecommunication (-1.07%), Engineering (-1.01%), Pharmaceuticals (-0.95%) and Food & Allied (-0.27%). Total turnover stood at BDT 6.3 billion (USD 75.5 million). United Power Generation & Distribution Company Ltd. (+4.4%) was the most traded share with a turnover of BDT 367.3 million.
