Daily Market Update


The market closed in green today. The benchmark index DSEX (+0.38%) gained 15.64 points and closed at 4,085.80. The blue-chip index DS30 (+0.54%), the Shariah-based index DSES (+0.45%), and the large cap index CDSET (+0.28%) closed at 1,372.09, 948.32, and 808.63 points respectively. All the large cap sectors posted positive performance today. NBFI booked the highest gain of 1.17% followed by Pharmaceutical (+0.40%), Fuel & Power (+0.39%), Food & Allied (+0.38%), Telecommunication (+0.28%), Engineering (+0.13%) and Bank (+0.05%). Block trade contributed 12.7% of the overall market turnover. Beximco Pharmaceuticals Ltd. (+1.5%) was the most traded share with a turnover of BDT 116 million.
