
Daily Market Update

Market closed in red today. The benchmark index DSEX (-1.02%) lost 55.54 points and closed at 5.375.29 points today. Both the blue chip index DS30 (-0.82%) and the shariah based index DSES (-0.92%) closed in red. All the large cap sectors showed negative performance today. Food & Allied posted the highest loss of 2.36% followed by NBFIs (-1.94%), Engineering (-1.58%)Banks (-1.34%),Power (-1.23%)Telecommunication (-0.21%) and Pharmaceuticals (-0.09%). Turnover stood at BDT 5.4 billion (USD 64.4 million). United Power Generation & Distribution Company Ltd. (-2.0%) was the most traded share with a turnover of BDT 175.8 million.
