Market closed in red


Market closed in red today. The benchmark index DSEX (-0.29%) lost 15.78 points and closed at 5,395.63 points today. Both the blue chip index DS30 (-0.18%) and the shariah based index DSES (-0.15%) closed in red. The large cap sectors showed mixed performance today except Pharmaceuticals (+0.10%) and Power (+0.07%). NBFIs posted the highest loss of 1.06% followed by Food & Allied (-0.62%), Telecommunication (-0.33%), Engineering (-0.27%), and Banks (-0.20%). Turnover stood at BDT 4.5 billion (USD 53.6 million). United Power Generation & Distribution Company Ltd (+0.8%) was the most traded share with a turnover of BDT 300.9 million.
