# **Daily Market Update**


Market closed in green today. The benchmark index DSEX (+0.33%) gained 17.76 points and closed at 5,429.04 points today. The blue-chip index DS30 (+0.15%) and shariah based index DSES (+0.50%) both closed in green. All the large cap sectors showed positive performance today except Telecommunication (-0.66%) and Banks (-0.19%). NBFIs posted the highest gain of 3.65% followed by Power (+0.82%), Pharmaceuticals (+0.59%), Engineering (+0.54%) and Food & Allied (+0.50%). Total turnover stood at BDT 7.0 billion (USD 84.6 million). Monno Ceramic (+4.9%) was the most traded share with a turnover of BDT 252.8 million.
