


Daily Market Update

Market closed in red today. The benchmark index DSEX (-0.57%) lost 25.14 points and closed at 4,384.48 points. The blue chip index DS30 (-0.54%). the Shariah-based index DSES (-0.75%), and the large cap index CDSET (-0.92%) all closed in red. All the large cap sectors showed negative performance today. Telecommunication experienced the highest loss of 2.17% followed by NBFIs (-1.61%), Fuel & Power (-1.18%), Food & Allied (-0.91%),Pharmaceuticals (-0.52%), Banks (-0.23%) and Engineering (-0.13%). Turnover stood at BDT 4.2 billion (USD 49.9 million). LafargeHolcim Bangladesh Limited (-2.3%) was the most traded share with a turnover of BDT 138.6 million.
