

Daily Market Update

Market closed flat in green today. The benchmark index DSEX (- Sector Index 0.38%) gained 21.61 points and closed at 5,710.07 points today. The blue chip index DS30 (+0.55%) and the shariah based index DSES (+0.61%) both closed in green. The large cap sectors showed positive performance today except for Banks (-0.64%) and Telecommunication (-0.15%). Food & Allied recorded the highest gain of 4.19% followed by Engineering (+0.88%), Power (+0.70%), Pharmaceuticals (+0.65%) and NBFIs (+0.15%). Turnover stood at BDT 4.62 billion (USD 55.6 million) which was 6.0% lower than the previous session's value. United Power Generation & Distribution Company Ltd (+1.8%) was the highest traded share with a turnover of BDT 283.7 million.
