
Indo-Bangla Pharmaceuticals Limited

Market closed in red today. The benchmark index DSEX (-2.40%) lost 101.53 points and closed at 4,129.96 points. The blue chip index DS30 (-2.27%), the Shariah-based index DSES (-2.22%), and the large cap index CDSET (-2.21%) all closed in red. All the large cap sectors showed negative performance today. Engineering experienced the highest loss of 4.15% followed **NBFIs** (-3.08%),by Telecommunication (-3.01%), Banks (-2.59%), Power (-2.32%), Pharmaceuticals (-0.79%) and Food & Allied (-0.25%). Turnover stood at BDT 4.1 billion (USD 49.3 million). Orion Pharma Ltd. (+9.0%) was the most traded share with a turnover of BDT 184.7 million.
