

**Daily Market Update** 

The market closed in green today. The benchmark index DSEX (+0.57%) gained 34.42 points and closed at 6,053.43. The blue-chip index DS30 (+0.38%), the Shariahbased index DSES (+0.67%), and the large-cap index CDSET (+0.20%) closed at 2,203.59, 1,293.17, and 1,234.31 points, respectively. Large-cap sectors posted  $\underset{\square}{\times}$  mixed performance today. Engineering booked the highest gain of 3.13% followed by Telecommunication (+0.92%), Pharmaceutical (+0.53%), and Fuel & Power (+0.18%). Bank experienced the highest loss of 0.74% followed by NBFI (-0.62%), and Food & Allied (-0.22%). Block trades contributed 3.2% of the overall market turnover. Bangladesh Export Import Company Ltd. (+2.4%) was the most traded share with a turnover of BDT 967 million.


