The market closed in red today. The benchmark index DSEX (-0.10%) lost 5.66 points and closed at 5,511.36. The blue-chip index DS30 (-0.34%), the Shariah-based index DSES (-0.55%), and the large-cap index CDSET (-0.24%) closed at 2,116.05, 1,248.16, and 1,179.14 points, respectively. Large-cap sectors posted mixed performance today. NBFI booked the highest gain of 1.24% followed by Bank (+0.54%), Telecommunication (+0.36%), Food & Allied (+0.01%). Pharmaceutical experienced the highest loss of 0.63% followed by Fuel & Power (-0.61%), Engineering (-0.24%). Block trades contributed 5.5% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.2%) was the most traded share with a


