
Market closed in green

The market closed in green today. The benchmark index DSEX (+0.16%) gained 10.69 points and closed at 6,892.99. The bluechip index DS30 (-0.19%), the Shariah-based index DSES (+0.33%), and the large-cap index CDSET (-0.14%) closed at 2,571.19, 1,456.12, and 1,380.89 points, respectively. All the large-cap sectors posted positive performance today. Pharmaceutical booked the highest gain of 0.77% followed by Telecommunication (+0.45%), Fuel & Power (+0.16%), NBFI (+0.11%), Engineering (+0.00%), Bank (-0.20%), and Food & Allied (-0.64%), respectively. Block trades contributed 0.7% of the overall market turnover. Bangladesh Export Import Company Ltd. (-2.7%) was the most traded share with a turnover of BDT 1,064 million.





Figure: Sectorial Mcap Change
