

BRAC EPL STOCK BROKERAGE LTD Daily Market Update

The market closed in red today. The benchmark index DSEX (-0.39%) lost 28.5 points and closed at 7,327.55. The blue-chip index DS30 (+0.86%), the Shariah-based index DSES (-0.01%), and the large-cap index CDSET (+0.71%) closed at 2,765.27, 1,593.75, and 1,476.49 points, respectively. All the large-cap sectors posted negative performance today. Fuel & Power experienced the highest loss of 1.04% followed by Bank (-0.85%), NBFI (-0.55%), Engineering (-0.34%),

Telecommunication (-0.33%), Pharmaceutical (+0.31%), and Food & Allied (+1.56%), respectively. Block trades contributed 0.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (+3.0%) was the most traded share with a turnover of BDT 1,767 million.


