
Market closed in green

The market closed in green today. The benchmark index DSEX (+1.15%) gained 76.08 points and closed at 6,699.39. The blue-chip index DS30 (+1.25%), the Shariah-based index DSES (+1.04%), and the large-cap index CDSET (+0.89%) closed at 2,427.57, 1,459.04, and 1,318.38 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 3.40% followed by Bank (+1.04%), Pharmaceutical (+0.79%), Fuel & Power (+0.58%), Engineering (+0.39%), Food & Allied (+0.06%), and Telecommunication (-0.64%), respectively. Block trades contributed 2.4% of the overall market turnover. Bangladesh Export Import Company Ltd. (+4.8%) was the most traded share with a turnover of BDT 2,591 million.


