
DSEX Index Closing 7,313.98 \$\psi\$ (-31.59, -0.43%)

Market closed in red

The market closed in red today. The benchmark index DSEX (-0.43%) lost 31.59 points and closed at 7,313.98. The blue-chip index DS30 (-0.27%), the Shariah-based index DSES (-0.35%), and the large-cap index CDSET (-0.64%) closed at 2,749.88, 1,591.04, and 1,462.49 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.75% followed by Telecommunication (-1.22%), Engineering (-0.97%), Fuel & Power (-0.74%), Food & Allied (-0.20%), Bank (+0.09%), and Pharmaceutical (+0.43%), respectively. Block trades contributed 0.3% of the overall market turnover. LafargeHolcim Bangladesh Limited (-3.9%) was the most traded share with a turnover of BDT 1,502 million.


