
Market closed in red

The market closed in red today. The benchmark index DSEX (-0.55%) lost 38.33 points and closed at 6,882.02. The blue-chip index DS30 (-0.72%), the Shariah-based index DSES (-0.48%), and the large-cap index CDSET (-0.70%) closed at 2,585.33, 1,460.32, and 1,391.17 points, respectively. All the large-cap sectors posted negative performance today. Food & Allied experienced the highest loss of 0.81% followed by Engineering (-0.45%), Fuel & Power (-0.31%), Pharmaceutical (-0.24%), Bank (-0.16%), Telecommunication (-0.06%), and NBFI (+0.74%), respectively. Block trades contributed 0.9% of the overall market turnover. GSP Finance Company (Bangladesh) Limited (+6.9%) was the most traded share with a turnover of BDT 488 million.






