

The market closed in green today. The benchmark index DSEX (+0.22%) gained 15.96 points and closed at 7,218.06. The bluechip index DS30 (-0.11%), the Shariah-based index DSES (+0.18%), and the large-cap index CDSET (+0.02%) closed at 2,635.15, 1,578.83, and 1,426.11 points, respectively. All the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 3.78% followed by NBFI (-3.33%), Food & Allied (-0.77%), Pharmaceutical (-0.53%), Telecommunication (-0.37%), Fuel & Power (+0.24%), and Bank (+1.11%), respectively. Block trades contributed 1.7% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.1%) was the most traded share with a turnover of BDT 1,496 million.


