


The market closed in green today. The benchmark index DSEX (+0.12%) gained 7.31 points and closed at 6,273.33. The blue-chip index DS30 (+0.04%), the Shariah-based index DSES (-0.07%), and the large-cap index CDSET (-0.13%) closed at 2,274.70, 1,353.10, and 1,251.34 points, respectively. Large-cap sectors posted mixed performance today. Food & Allied booked the highest gain of 0.27% followed by Pharmaceutical (+0.24%), Engineering (+0.13%). NBFI experienced the highest loss of 1.13% followed by Telecommunication (-0.58%), Fuel & Power (-0.13%), Bank (-0.06%). Block trades contributed 6.8% of the overall market turnover. Bangladesh Export Import Company Ltd. (+0.4%) was the most traded share with a turnover of BDT 1,199 million.




**Figure: Sectorial Mcap Change**

#### ICBIBANK

Pre-IPO Net Asset Value (NAV) per share (considering Pre-IPO paid up shares) would be BDT 27.07 as on 31 March 2021 and the same would be Tk. 28.53 (considering Post-IPO paid up shares). Pre-IPO weighted average paid-up number of shares for 3 (three) months (January-March 2021) and 9 (nine) months (July 2020-March 2021) period ended on 31 March 2021 was 99,225,000 which was same for the same period of the previous year and Post-IPO paid-up number of shares would be 172,995,488.
