

Market closed in red

The market closed in red today. The benchmark index DSEX (-0.07%) lost 5.17 points and closed at 7,243.27. The blue-chip index DS30 (+0.06%), the Shariah-based index DSES (+0.05%), and the large-cap index CDSET (+0.14%) closed at 2,719.14, 1,567.44, and 1,449.06 points, respectively. All the large-cap sectors posted positive performance today. NBFI booked the highest gain of 0.84% followed by Food & Allied (+0.62%), Engineering (+0.14%), Fuel & Power (+0.13%), Telecommunication (+0.03%), Bank (-0.33%), and Pharmaceutical (-0.41%), respectively. Block trades contributed 0.6% of the overall market turnover. Fortune Shoes Limited (+7.2%) was the most traded share with a turnover of BDT 957 million.


