

The market closed in red today. The benchmark index DSEX (-1.07%) lost 77.55 points and closed at 7,140.50. The blue-chip index DS30 (-0.89%), the Shariah-based index DSES (-1.43%), and the large-cap index CDSET (-1.01%) closed at 2,611.69, 1,556.22, and 1,411.69 points, respectively. All the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 2.08% followed by Fuel & Power (-1.79%), Food & Allied (-1.38%), Telecommunication (-1.33%), Pharmaceutical (-0.99%), Bank (-0.77%), and NBFI (+1.25%), respectively. Block trades contributed 2.4% of the overall market turnover. LankaBangla Finance Ltd. (+1.0%) was the most traded share with a turnover of BDT 1.115 million.


