
# Market closed in red

The market closed in red today. The benchmark index DSEX (-0.23%) lost 15.32 points and closed at 6,771.85. The blue-chip index DS30 (+0.19%), the Shariah-based index DSES (-0.19%), and the large-cap index CDSET (+0.07%) closed at 2,426.83, 1,466.26, and 1,326.56 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.69% followed by Bank (-1.40%), Telecommunication (-0.38%), Food & Allied (-0.27%), Pharmaceutical (-0.25%), Engineering (+0.25%), and Fuel & Power (+1.05%), respectively. Block trades contributed 3.2% of the overall market turnover. Bangladesh Export Import Company Ltd. (+3.8%) was the most traded share with a turnover of BDT 1,304 million.


