
Market closed in red

The market closed in red today. The benchmark index DSEX (-1.24%) lost 89.19 points and closed at 7,097.27. The blue-chip index DS30 (-0.98%), the Shariah-based index DSES (-1.37%), and the large-cap index CDSET (-0.96%) closed at 2,678.56, 1,525.18, and 1,434.14 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 2.57% followed by Food & Allied (-1.74%), Pharmaceutical (-1.21%), Engineering (-1.20%), Fuel & Power (-1.01%), Telecommunication (-0.88%), and Bank (-0.51%), respectively. Block trades contributed 0.2% of the overall market turnover. Orion Pharma Ltd. (+3.4%) was the most traded share with a turnover of BDT 898 million.


