

# **Daily Market Update**

The market closed in green today. The benchmark index DSEX (+0.28%) gained 16.65 points and closed at 6,069.41. The blue-chip index DS30 (+0.47%), the Shariahbased index DSES (+0.44%), and the large-cap index CDSET (+0.32%) closed at 2,207.30, 1,296.60, and 1,228.85 points, respectively. All the large-cap sectors  $\underset{\square}{\times}$  posted positive performance today. Bank booked the highest gain of 1.19% followed by NBFI (+0.76%), Pharmaceutical (+0.65%), Engineering (+0.53%), Fuel & Power (+0.52%), Food & Allied (+0.36%), and Telecommunication (-0.25%), respectively. Block trades contributed 13.1% of the overall market turnover. Pioneer Insurance Comapny Ltd. (-4.8%) was the most traded share with a turnover of BDT 1,632 million.


