
DSEX Index Closing 5,349.78 ↓ (-84.91, -1.56%)

Market closed in red

The market closed in red today. The benchmark index DSEX (-1.56%) lost 84.91 points and closed at 5,349.78. The blue-chip index DS30 (-1.90%), the Shariah-based index DSES (-1.70%), and the large-cap index CDSET (-1.52%) closed at 2,034.57, 1,226.48, and 1,139.64 points, respectively. All the large-cap sectors posted negative performance today. Engineering experienced the highest loss of 3.28% followed by Telecommunication (-1.97%), NBFI (-1.96%), Pharmaceutical (-1.79%), Fuel & Power (-1.54%), Food & Allied (-1.08%), and Bank (-0.58%), respectively. Block trades contributed 10.0% of the overall market turnover. Bangladesh Export Import Company Ltd. (-3.9%) was the most traded share with a turnover of BDT 842 million.


