
DSEX Index Closing 6,842.23 ↑ (+81.61, +1.21%)

Market closed in green

The market closed in green today. The benchmark index DSEX (+1.21%) gained 81.61 points and closed at 6,842.23. The blue-chip index DS30 (+1.17%), the Shariah-based index DSES (+1.26%), and the large-cap index CDSET (+0.99%) closed at 2,451.89, 1,479.72, and 1,335.77 points, respectively. All the large-cap sectors posted positive performance today. Bank booked the highest gain of 1.93% followed by NBFI (+1.68%), Telecommunication (+0.92%), Fuel & Power (+0.86%), Pharmaceutical (+0.67%), Engineering (+0.63%), and Food & Allied (-0.12%), respectively. Block trades contributed 2.3% of the overall market turnover. Bangladesh Export Import Company Ltd. (+1.1%) was the most traded share with a turnover of BDT 1,539 million.



The amount of rent is USD 3,03,514.50 or equivalent Bangladeshi Taka per annum. In this regard IFAD Autos Limited has paid to the Bangladesh Economic Zones Authority (BEZA) a sum of BDT 5,15,67,114.00/- equivalent to USD 6,07,029.00 only as Security Deposit which is equivalent to Two Years Annual Lease Rent for the demised land.
