
Market closed in red



The market closed in red today. The benchmark index DSEX (-0.77%) lost 51.83 points and closed at 6,702.61. The blue-chip index DS30 (-0.96%), the Shariah-based index DSES (-0.71%), and the large-cap index CDSET (-0.92%) closed at 2,511.99, 1,423.65, and 1,352.71 points, respectively. All the large-cap sectors posted negative performance today. NBFI experienced the highest loss of 1.17% followed by Food & Allied (-0.96%), Engineering (-0.95%), Fuel & Power (-0.87%), Pharmaceutical (-0.61%), Bank (-0.45%), and Telecommunication (-0.37%), respectively. Block trades contributed 0.9% of the overall market turnover. Fortune Shoes Limited (-2.6%) was the most traded share with a turnover of BDT 542 million.






