
## **DSEX Index Closing 7,250.60** ↑ (+8.76, +0.12%)

The market closed in green today. The benchmark index DSEX (+0.12%) gained 8.76 points and closed at 7,250.60. The bluechip index DS30 (+0.01%), the Shariah-based index DSES (-0.09%), and the large-cap index CDSET (-0.09%) closed at 2,673.56, 1,581.05, and 1,439.31 points, respectively. All the large-cap sectors posted positive performance today. Engineering booked the highest gain of 1.55% followed by NBFI (+0.38%), Food & Allied (+0.17%), Pharmaceutical (+0.07%), Bank (+0.06%), Fuel & Power (-0.03%), and Telecommunication (-0.53%), respectively. Block trades contributed 5.0% of the overall market turnover. Bangladesh Export Import Company Ltd. (-0.1%) was the most traded share with a turnover of BDT 969 million.


